#### 1. Introduction: challenges for 2023

The year of 2023 would be dedicated to the planning of DINÂMIA'CET-Iscte (DC-Iscte) pluriannual assessment. It is also time to take stock of the work carried out and to define DC-Iscte overall strategy for the coming years. Therefore, the priority should be the design of the strategic plan, the associated research options, and the tools to implement those options. This endeavor calls for the engagement of all members in the theoretical and methodological debates that will format the future research.

First and foremost, a discussion on the identity matrix must be relaunched in the context of the increasing number of researchers, diversified members' interests, scientific domains, methodological options, and economic, social, political, and cultural challenges. The research in the next years will continue to focus on the impacts of the pandemic, but also on the unknown consequences of the Ukraine war. In other words, the study of successive crises is unavoidable in a Centre dedicated to socioeconomic and territorial change.

Additionally, the DC-Iscte is challenged to improve its interaction with the society and engage in the design of public policies in a variety of domains. Some of this work has already started in 2022, but the socioeconomic environment demand for more and better solutions from the academics. The issues related to housing and youth employment have already made much progress, but they are still relevant and will continue, at least, in the next couple of years. The research on climate change, sustainable development, digital transition, ecological transition, varying ways of intervening in the territory and others deserve due attention from DC-Iscte members.

These topical subjects involve research activities and proposals to raise policy makers awareness to the fact that there is little time to make decisions and intervene. It requires, in addition, improving the communication of research results to non-academic audiences, and engagement with stakeholders and civil society in the design of solutions. This major openness to the civil society will remain one of the guiding goals of DC-Iscte's activity. The Centre intends to intensify the engagement of researchers in the Sociodigital Lab for Public Policies, not only to develop research activities but also to organize scientific events on topical subjects and participate actively in other activities.

The selected research topics and policy concerns involve inter, multi and transdisciplinary approach. This openness to articulate different scientific fields is already a key feature of the Centre, and it has been a source of attraction for external researchers, both national and international. Furthermore, the evolving national and international environments reinforce the work of the thematic lines along the three Research Groups (RG's), as well as the mobilization of the three Integrating Thematic Lines (ITL).

For this purpose, regular meetings will be held, throughout the year, to reach a larger number of researchers, encourage them to apply for project from

diversified funding sources and, finally, contribute more actively to the strategy of the DC-Iscte. This involves a careful analysis of the research developed so far and, next, to help less-active members to pursue a research agenda that assist them to position in the national and international arena.

The pattern of dissemination is expected to maintain like the previous years and taking advantage of the range of publication types. Researchers will, however, encouraged to improve publications in the indexed journals. The international scientific events already defined will focus on housing policies; digital transition and its relationship with labour law; populism, among others. As usual in the architecture field, there will be exhibitions involving civil society stakeholders. These events can accommodate conferences and debates organized by DC-Iscte members.

In parallel, DC-Iscte will continue to strengthen its in-house publications both the regular Working Papers series, and journals *Passagens* - with a new issue scheduled for 2023 – and the indexed journal *Cidades, Comunidades e Territórios* (CTT). This Journal continue to welcome special issues and will have a new image in 2023. The relevance of this publication is reflected in the fact that in its thematic area (Urban Studies), there are only two Portuguese journals with a Q2 classification (none with Q1), and CTT is the only one with a diamond open access policy.

The education and training linked to DC-Iscte allow host PhD and master students, who prepare their dissertations with researchers and/or professors of the Centre. The launch of the Master's in Architecture and Visual Culture in Lisbon, to be hosted by DC-Iscte, is also worth emphasizing stemming from a Partnership Agreement between Lisbon City Council and Iscte.

At an organizational level, DC-Iscte board members will continue to set regulations and reorganize the RGs coordination. Those regulations regard the general rules governing the Centre; the scientific awards, which became a responsibility of the research centres in Iscte; the rights and duties of members; among others. Greater efforts will be made to reallocate the DC-Iscte in the new building dedicated to research at Iscte, the Center for Valorization and Transfer of Technologies (CVTT), which is at the finale stage of construction.

The DC-Iscte continues to be deeply engaged in communication improvement plan, notably, updating the website and newsletter for external visibility, and improving internal communication channels. A new science communication podcast will also be launched, which intends to translate the research carried out by the Unit researchers to non-specialized audiences, demonstrating its impacts on our daily lives.

Finally, informal meetings of the team are planned, as well as the annual DC-Iscte Workshop, that will be held in May. It is the 7<sup>th</sup> edition, and it will include special stream to discuss research strategy for the next years with special focus on the new challenges for the Portuguese economy and society. It is assumed that 2023 might be the beginning of a new cycle.

#### 2. Strategic Goals for 2023

DC-Iscte strategic goals have been designed on the basis of its legacy of theoretical and empirical research, and accumulated experience of cooperation with other national and international research units, as well as a history of collaboration with public entities and civil society since it was founded.

Generally, major goals defined in its mid-term Strategic Plan (submitted to FCT within the framework of the assessment process and funding application for the period of 2018-2022<sup>1</sup>) bind DC-Iscte:

- to research work on cross-cutting and comprehensive topics addressing the key dynamics of contemporary socio-economic and territorial change and the inherent challenges to regulation and governance;
- to the mobilization of its researchers towards innovation in research and communication methods, for intra- and interdisciplinary dialogue, along with strengthened co-operation with their national, foreign and international counterparts in research;
- to greater openness to society.

This general strategic framework for the period of 2018-2022 (meanwhile considered the backbone for the funding programme from FCT for 2019-2023) becomes the structural background framework for the 2022 activity plan, and can be translated into a set of goals which are transversal to the **three main level of objectives that guide the unit's scientific and operational strategy:** 

- 1. <u>Main scientific objectives to be pursued by the Unit</u> addressing the mission and collective scientific identity of DC-Iscte and its research programmes; the scientific objectives pursued by each Research Group (RG) and respective Thematic Lines; the objectives pursued by the Integrating Thematic Lines (ITL);
- 2. <u>Main mid-term operative goals linked to the Unit's Strategic Plan</u> addressing the Unit's development and the expected activities for 2023;
- 3. <u>Specific goals established for 2023</u> addressing short term objectives planned for implementation in 2023.

Table 1 presents, in a transversal and summarized way, the activities referring to the main goals to accomplish through the three levels of scientific and operational objectives that guide DC-Iscte Strategic Plan. Most of them correspond to actions already underway and which require continuity. Others, due to the punctual or occasional circumstances in which they arise, follow a scheduled planning.

#### 3. Main Goals for 2023 by Research Group

#### 3.1. INNOVATION AND LABOUR (IL)

Coordinators: Isabel Salavisa and Fátima Suleman

**Keywords:** science and technological innovation; sustainable transition; digital transition; skills; quality in work and employment; youth employment.

#### **Thematic Lines**

#### 1. Innovation (Coord: Isabel Salavisa)

Keywords: technological innovation; climate and ecological transition; energy; technologies for sustainability; research & innovation policies; decarbonization of economic activities.

Regarding Innovation, the Group works on the acceleration of transition to sustainability of large sociotechnical systems, like the energy and food systems, and the decarbonization of economic activities. One of the main topics of research is the role of demand-side action for rapid and effective climate mitigation. The other main topics of research are: intellectual capital management; impacts of technological change; and the emergence and role of actors, values, norms, policies and forms of governance in these processes.

#### 2. Labour (Coord: Fátima Suleman)

Keywords: labour market and segmentation; youth employment; higher education and training; quality of work and employment; digital work and regulation; climate transition and employment.

The Labour group works on contemporary labour market issues in Portugal and the EU: employability of young people and its drivers; ageing and older people social and economic issues; labour market regulation; and firms functioning. The research topics include: education and skills; work, job quality; telework and working conditions; youth employment and unemployment; local youth employability; traditional and new vulnerable workers; industrial relations and trade unions; social protection; firms' options regarding human resources and governance.

Continuing interaction with policy makers and other bodies concerned with labour issues is an objective. It includes the engagement of the Youth Employment Observatory in the implementation of the *More and Better Jobs for Young People* agenda and the participation in a project conducted by the

Taskforce on Social Security Sustainability on youth perception on social security and retirement reforms.

#### 3.2. CITIES AND TERRITORIES (CT)

Coordinators: Pedro Costa and Teresa Costa Pinto

**Keywords:** contemporary socioeconomic environmental and cultural change; territorial dynamics; local/regional development policies; territorial planning and governance; sustainable development; reflective action-research; food system.

The main scientific objectives of this Research Group are:

- A. Reflect on the thematic lines existing in this RG and their adequacy (and possible adjustments) in the face of the evolution and dynamics of the group, within the framework of the process of preparation of the international evaluation of DC-Iscte;
- B. To deepen the development of collective work dynamics in small groups within the RG (non-exclusive, generated from bottom-up dynamics, via organization of researchers' interests), gathered around diverse specific themes, in "clusters" of collective and individual projects, which are at the international and national forefront of the research in their areas;
- C. Continue with the various ongoing projects, according to the respective activity plans and timetables, and continue the effort to submit applications (collective and individual) for new calls, with particular emphasis on European funding, as well as projects applied to reality and corresponding to social demand, for various institutions, both public and private;
- D. Continue the effort of qualitative and quantitative expansion of the scientific production of the group, namely through internationalized publication, whether of books or scientific articles, along with the promotion of the effort to publish research results for wider audiences and for society in general;
- E. Continue the effort of collaboration with the public authorities and various stakeholders, in the design, monitoring of implementation, and evaluation of public policies and territorial planning, at the various territorial scales;
- F. Deepen the creation, production and collection of data and information (quantitative and qualitative) made available in open access to stakeholders, other researchers, and users in general;
- G. Continue and deepen the logic of participatory work and co-construction of knowledge with stakeholders, in the design of projects, the research methodologies used, and in the mechanisms of dissemination of results, continuing the tradition long rooted in the group of "action research", as well as methodological experimentation, along with openness to conceptual and methodological plurality in the research carried out.

#### **Thematic Lines**

## 1. Creativity, culture and territory (*Criatividade, Atividades Culturais* e *Território*) (Coord: Pedro Costa)

Keywords: territorially embedded creative/cultural dynamics; creative districts/ecosystems; artistic intervention; art and public space; cultural participation; cultural/creative tourism.

The main scientific objectives of this Thematic Line are:

A. To develop conceptual and empirical work on the role of cultural activities in the promotion of territorial development and inform territorially-based cultural planning;

- B. To develop conceptual and empirical work in order to understand the role of urban milieus in the development of creativity and cultural activities;
- C. To develop conceptual and empirical work in the assessment of the multidimensional impacts and effects of cultural activities in terms of sustainable development processes.
- D. To disentangle the socioeconomic functioning of cultural activities, creation processes, audiences, and their relation with the territory (in specific empirical cases: e.g., performing arts, architecture, alternative music, photo festivals);
- E. To study and put into practice and test urban interventions and art in public spaces;
- F. To study, conceptually and empirically, and to help the development of creative tourism practices, particularly in low-density areas;
- G. To further explore the relation between art, heritage, architecture, history and territories;
- H. To develop the exploration of new methodologies and concepts for artistic urban interventions and to enhance participation-research methodologies.

Ongoing projects will be continued (with particular emphasis on Stronger Peripheries, and its activities, including the organization of an international workshop in Lisbon), as well as the preparation of a significant set of applications (including calls from the Horizon programme, Creative Europe and SUDOE, as well as national competitive calls, both collective and individual).

It will continue the dissemination of research results to society and coproduction of knowledge with stakeholders, either within the scope of the activity of ongoing projects, or at the invitation of various entities (e.g., Municipality of Torres Vedras, São Luiz Municipal Theater, Artemrede, MIL Festival,...)

It is planned to hold the internal Thematic Line seminars on a bimonthly basis, and it is envisaged a very representative participation of TL researchers in the III International Conference "Todas as Artes" (co-organized by DC), to be held in Porto (where more than 20 DC articles will be presented, by more than 25 authors, related with the issues of culture, creativity and territory), in addition to disseminating the work carried out in multiple other international and national scientific meetings.

It will continue the exploration of new methodologies of action-research, coconstruction of knowledge and urban intervention, in particular using art and artistic knowledge in the production of scientific research, within the scope of several individual and collective research projects of this TL.

# 2. Representations and discourse on architecture and territory (Representações e Discurso sobre Arquitetura e Território) (Coord: Paulo Tormenta Pinto)

Keywords: representation and discourse in architecture; architecture/urbanism history; architectural/urbanism theory; architectural practice and teaching; heritage.

The main scientific objectives of this Thematic Line are:

- A. To debate the impact of social and economic policies in the physical territory;
- B. To understand the relationship between the discourse and its geographical representation;
- D. To conceptualize the history of architecture and urbanism as a consequence of ideological processes;
- C. To explore the mechanisms of representation as a methodology to define the borders of research;
- D. To explore different supports of representation to fixe data and define new research fields;
- E. To understand mapping as tool articulate different layers of territorial time.

## 3. Ways of Living, Society and Architectural Culture (*Modos de Habitar, Sociedade e Cultura Arquitectónica*) (Coord: Ana Vaz Milheiro)

Keywords: architectural culture and history; housing; ways of living; colonial/post-colonial perspectives; violence and control through housing; middle class mass housing.

The main scientific objectives of the Thematic Line are:

A. Analysis of the private housing market dynamics, residential trajectories and their relationship with the social recomposition of territories and ways of inhabiting;

- B. Support to the formulation, implementation and evaluation of public policies, including rehabilitation and urban regeneration;
- C. Analysis of the morphologic dimension of housing projects and their urban insertion;
- D. Study of the urban development processes in colonial and post-colonial contexts (with particular focus on Portuguese-speaking African countries, Macao and Brazil).

# 4. Recompositions, metropolitan change and housing (*Recomposições, mudança metropolitana e habitação*) (Coord: Teresa Costa Pinto, Mª Assunção Gato and Sandra Marques Pereira)

Keywords: contemporary housing systems; socio-economic recompositions; metropolitan dynamics of change; care; precarious housing.

The main scientific objectives of this Thematic Line are:

- A. To understand the dynamics of recomposition and change in the Lisbon Metropolitan Area and to assess the several effects resulting from these changes, while developing comparative analyses with other territories;
- B. To understand the metropolitan transformation dynamics, with particular focus on suburban and peri-urban areas and on restructuring areas, not neglecting small and medium-sized cities;
- c. To conceptualize and empirically inform the relations between territorial change and globalized processes of economic, social, and cultural transformation, focusing on the effects produced in cities and their populations;
- D. To analyze socioeconomic and territorial recompositions in light with tourism, consumption practices, lifestyles and quality of life;

- E. To understand and analyze the contemporary housing problems, the residential practices, and the dynamic relations with care, in line with market transformations and public policies;
- F. To develop the comprehensive relationship between new forms of housing and working, and new formats of urban hybridisms and their intersections with the green transition and regenerative territories.

# 5. Territorial governance, spatial planning and socio-spatial intervention (Governação territorial, ordenamento do território e intervenção socio-espacial) (Coord: Maria Fátima Ferreiro)

Keywords: territorial governance; formal and informal spatial planning processes; participation; citizen's and social movements; public policies and territorial and social impacts assessment; local/regional/urban development policies; food systems and transition paths.

The main scientific objectives of this Thematic Line are:

- A. To analyze the relationship between development, territorial cohesion and regional and local planning and policies;
- B. To assess and help monitor public policies, namely at local/regional level, developing public advising in the diverse fields related to urban planning and territorial development;
- C. To help the design of public policies related with spatial planning and strategic planning of territories and cities;
- D. To discuss governance issues and contribute to the theoretical development of the analysis on governance, public policies and planning methodologies;
- E. To understand the role of community-rooted development mechanisms, participation and urban social movements;
- F. To promote the deepening of the analysis of the governance processes of territorial systems and planning strategies.

## 6. Urban Morphology and Sustainability (*Morfologia Urbana e Sustentabilidade*) (Coord: Teresa Marat-Mendes)

The main scientific objectives of this Thematic Line are:

- A. To participate in the production of knowledge about the impacts of financialization to the Portuguese economy and society;
- B. To critically analyze how European citizens have been exercising their political and social rights in the wake of the economic crisis;
- C. To critically analyze the multidimensional and cumulative economic, social and political impacts of the economic crisis and to assess their permanent feature;
- D. To contribute to the development of a comprehensive approach to the impacts of the successive and cumulative crisis integrating, in particular, the following dimensions: a) the disjuncture between located experimented consequences and globalization trends; b) the different sectoral dynamics in response to the crisis in terms of wages, employment, working conditions and inequality; c) the state's intervention and the national and European political answers to the crisis; c) the political alternatives to re-link the economy with society;
- E. To shape concepts for debating the impact of economic discourses, especially in relation to successive and cumulative crisis and its relationship to the support of certain economic policies;
- F. To critically analyze how European law and regulation is addressing the risks to human rights arising from digital technologies' applications.

The main scientific objectives of this Thematic Line are:

- A. To participate in the production of knowledge about the scientific world and its relationship to its environment, paying particular attention to the impact on this relationship of the successive and cumulative crisis and the political responses to them;
- B. To take advantage in this reflexive exercise of recent developments in social theory;
- C. To contribute to the development of tools for evaluating the impact of scientific research;
- D. To shape concepts for debating politics of science;
- E. To provide individual researchers and research organizations with the appropriate tools to analyze the contexts in which they operate, and to define their own line of action:
- F. Cross-cutting these different objectives: to pay particular attention to the relationship between specialists and non-specialists, as intersecting with other major societal divides.

Research perspectives and methodologies should include the development of meta-theoretical and methodological enquiry on:

- Empirical and inter/transdisciplinary research in general;
- Socio-legal research (regarding the central debates of the RG and the role of socio-legal enquiry itself); and
- Discourse and argumentation analysis.

# 4. YOUTH EMPLOYMENT OBSERVATORY AND LXHABIDATA: MAIN GOALS FOR 2023

#### **4.1. YOUTH EMPLOYMENT OBSERVATORY (YEO)**

In line with its mission, the Observatory planned activities for 2023 are:

- produce policy briefs on specific subjects related to youth employment based on the studies conducted throughout the year;
- strengthen its presence in the media and social networks;
- disseminate the studies of the YEO team and other studies focused on youth employment;
- develop new partnerships at national and regional levels;
- update key indicators on the website (including specific data on graduates).

In addition to these more general objectives, the members of the Observatory team target the following goals:

#### 1. 'More and Better Jobs for Young People' Pact, José Neves Foundation

Following the White Paper 'More and Better Jobs for Young People', the José Neves Foundation is coordinating a pact, signed by more than 50 large national companies, which commit to quantify youth employment initiatives. The YEO is included as a partner in the project, with the responsibility of monitoring the data collected by the involved companies.

# 2. Youth survey on old age pensions, Commission for the Sustainability of Social Security

The YEO has been invited as a partner of the project targeting the study of the perception of young people of retirement pensions. This project is included in the Social Security Sustainability task force created by the Government, and the YEO is working with Observatory of Inequalities (Iscte) to design the survey to be applied to young people. The two observatories will perform the data analysis, prepare a report, and guarantee the dissemination of the results.

#### 3. Partnership with IEFP - Institute of Employment and Vocational Training

The YEO plans to sign a 3-year protocol with IEFP at the beginning of the year. In this context, a study to identify the profiles of unemployed youth in Portugal was defined for 2023.

#### 4. Partnership with Valongo City Council

A study of the labour market and the qualifications of young people in the Norte region is planned, as well as the public presentation of the conclusions.

#### **4.2. LXHABIDATA**

2023 will be a year of transition for LxHabidata. It is expected to hire two researchers with different profiles, focused on distinct functions, that will ensure the planned activities listed below:

- update of existing indicators and creation of new ones;
- review of data presentation/visualization;
- creation of the Lisbon Metropolitan Area Housing Observatory, whose initial team will include LxHabitada platform team and also the researchers Ana Brandão and Joana Lages;
- realization of a conference to launch the Observatory (October), which will have an international keynote speaker and the presentation of a study based on LxHabidata data.
